

Disaster Event – South East Queensland Low, 30 April – 1 May 2015



Event and Timing –

A low crossed south east Queensland between Thursday 30 April and Friday 1 May 2015, bringing heavy rainfall and flash flooding to the area.

Assistance Activated –

The Minister for Police, Fire and Emergency Services, The Honourable Jo-Ann Miller, MP activated the Commonwealth/State-funded Natural Disaster Relief and Recovery Arrangements (NDRRA).
